

ORDINANCE NO. 6-11

AN ORDINANCE TO AMEND SECTION 3-227 OF THE CITY CODE; TO INCREASE SEWER REVENUES BY 6.3% PER YEAR FOR THE NEXT TWO FISCAL YEARS; TO REPEAL THE ORIGINAL SECTION 3-227; TO PROVIDE FOR A TIME WHEN THIS ORDINANCE SHALL TAKE EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SEWARD, NEBRASKA THAT:

Section 1. Amendment. Section 3-227 of the Municipal Code of Seward, Nebraska, is amended to read as follows:

Section 1. MUNICIPAL SEWER DEPARTMENT: SEWER USE RATES.

RESIDENTIAL RATES

Residential Rates shall be based on an average of the water consumption billed in January, February and March. The sewage contribution of a new residential user who has not established an average for the months of January, February and March, or a user who only has sewer and has no water usage on which to base a charge, shall be charged, in the following manner:

Single occupancy	200 C.F. per month, plus the min. sewer chg.
Double or more occupancy	600 C.F. per month, plus the min. sewer chg.
No water meter	600 C.F. per month, plus the min. sewer chg.

The Charges are:

RESIDENTIAL SEWER USE RATES
Customer Charge of \$14.76 per meter,
plus \$.0276 per Cubic Feet

Effective October 2012 Billing:

RESIDENTIAL SEWER USE RATES
Customer Charge of \$16.00 per meter,
plus \$.0287 per Cubic Feet

GENERAL SERVICE RATES (Formerly COMMERCIAL)

General Services Rates are based upon actual water consumption each month.

The Charges are:

Effective October 2011 Billing:

GENERAL SERVICE SEWER RATES
Customer Charge of \$21.24 per meter,
plus \$.0276 per Cubic Feet

MUNICIPAL RATE

Municipal Rates shall be billed according to use as determined by meter for all municipal accounts.

The Charges are:

Effective October 2011 Billing:

MUNICIPAL USE

Customer Charge of \$8.50 per meter
plus \$.0276 per Cubic Feet

Effective October 2012 Billing:

MUNICIPAL USE (Same as General Service)

Customer Charge of \$23.79 per meter
plus \$.0287 per Cubic Feet


Section. 2. REPEAL. All ordinances or provision or portions of ordinances in conflict here with are hereby repealed.


Section 3. WHEN OPERATIVE. This ordinance shall take effect and be in full force from and after its passage, approval and publication in pamphlet form as required by law.
